Note: The payment for the second installment is due before December 31st, and failure to meet this deadline will result in the application of late fees as per our policy.

Note: Fine of Rs. 250 per day is applicable from the last revised due date until the full fee amount is paid.

- Payment is to be made online. The MIT-WPU hostel admin team will share the link with the parents. Once the payment is made, the same will be confirmed by the MITWPU hostel admin team.
- → Post verification of the payment receipt, a bed will be allotted under the name, and the details of the allotment will be shared by the MIT-WPU hostel team.
- * Room allotments shall be made on a first-come, first-served basis, based on the application submitted by the candidate in a prescribed format. The hostel room is allotted only to those who have made the full university fees and hostel fees, including mess.
- Admissions begin in the month of August each year. In case of late admissions, the fees will be calculated on a prorata basis.
- * Refund of hostel fees and mess charges, in case of cancellation of hostel admissions, shall be as follows:

MESS POLICIES AND TIMINGS

Following mess timings are to be followed at the hostel by the students:

Students are expected to adhere to the following rules and regulations

- ★ The students are required to be present only during the specified times for breakfast, lunch, and dinner.
- ♦ The students are expected to maintain proper decorum during mess hours.
- Wastage of food must be avoided.
- Separate dining sections are available for boys and girls; they should not sit together during meals.
- No student is allowed to take food from the dining area to their rooms, in case of medical conditions, they are required to get permission in advance.
- ♦ Outside food is not allowed in the mess premises.
- ♦ Mess properties should not be taken outside the mess premises. Doing so will result in a penalty.
- Non-hostellers shall not be allowed to enter the mess premises.

HOSTEL POLICIES

On Boarding and Payment Process

- → Hostel fee payment is to be made online, the MIT-WPU hostel admin team will share the link with the parents. Once the payment is made, the same will be confirmed by the MIT-WPU hostel admin team. Post verification of the payment receipt, a bed will be allotted under the name and the details of the allotment will be shared by the MIT-WPU hostel team.
- Onboarding will start a weak before the commencement of the respective program.
- * KYC completion would require an Aadhar card, parents' Aadhar card, a passport-size photograph, undertakings, a medical clearance certificate, and a native address at the time of onboarding.

Bus Allotment Policy

- Buses will be allotted based on the slots for the particular programmes, as communicated by the University.
- ❖ The bus schedule will be given to the students upon joining the hostel.

Common Area/Reading Room/Games Policy

- → All common areas/recreational areas except reading rooms will be closed post 9 pm. Damage/breakage/theft of any assets or articles in the said area will be recovered from the students present in that session.
- TT table and snooker Students need to bring their own rackets and TT balls to play. Damage or misplacement to any of the assets after the session will be recovered from the students present in that session.
- ▶ Board games will be provided by the warden for each session. Damage or misplacement to any of the board games or items in games will be recovered from the students present in that session

Washing Machine Policy

- ♦ Use of washing machine is allowed only for the washing of regular clothes/undergarments.
- ♦ Penalties will be issued for the misuse of washing machines

Noise Policy

- No use of speakers, mobile phones with loudspeakers, or TV is allowed with a sound range above 45 (decibels), as it can disturb the roommates, neighbors, and hostel staff.
- ♦ Any instance of such nature would result in penalties with amount up to Rs 10,000/-

Notice Board Policy

- Notices and flyers on the noticeboards are to be placed only by the hostel authorities.
- Any misplacement or damage, illicit posters, religious sayings, or fixing notices from students' end on common notice boards would impose penalties up to Rs 500.



Attendance of Students in Hostel

- Attendance will be marked twice every day, in the morning and at night without fail.
- Anyone entering the property after 9 pm without prior information will be deemed a latecomer. +
- The latecomer will have to sign a separate register.
- Regular occurrences of late arrivals at night may invite disciplinary action.
- The in-time at the hostels will be from 6 am to 9 pm.

Fine for Latecomers

- Latecomers on or after 9 pm on any given day, except those permitted by the hostel dean/supervisors/agents, will be liable to pay a fine of Rs. 1,000/- per delay.
- If the delay continues for a period of more than 3 consecutive days, then the parents of latecomers will be informed about the same.
- If any latecomer signs or tries to sign on behalf of any other hostel student, then both the latecomer and the student who signs on behalf of the latecomer will be fined, which shall amount to Rs. 1,500/-.
- Fines collected will be used for student-related activities.

Use of Electronic / Electric items and Furniture

- * Fixtures: Students are prohibited from bringing any additional electrical gadgets that require charging or consume power other than the fixtures in the room (excluding mobile chargers and laptop chargers).
- Damage to electronic/electric items and furniture: During their stay in the hostel, students are expected to take adequate care of the electronic/electric items and furniture provided by the hostel. Any damage to the hostel's property will be recovered from the students.
- Interchange of Furniture/Fixture: Students are not allowed to interchange any furniture/fixture from one location to another within the hostel. The students involved will be subject to a penalty recovery and may be expelled from the
- * Assets in Common Areas/Corridors: Theft/damages to hostel assets in common areas/corridors shall be recovered from all students of the flank/wing involved.
- In case of theft/damage to items that pertain to usage by the complete hostel, the recoveries shall be made from all the occupants of the hostel.

Issues Related to Parents /Relatives / Visitors

- Parents/Guardians should submit the undertaking to cooperate with the hostel authorities and should be available on call as and when required and disclose all contact details.
- Parents/Visitors are advised not to insist on entry beyond the designated area or visiting room as it might disturb other students.

Cancellation and Fees Refund

A refund will be initiated only in the event of the government imposing any restrictions, that too at the discretion of the management.

Electricity Policy

- As per the policy, a bill of Rs. 300 per student per month is considered. However, if the electricity consumption cost exceeds Rs. 300 per student, then the student will be liable to pay the extra charges. Reconciliation will be done every 6 months. This policy is implemented due to the following reasons:
- Extra equipment such as kettles, hair straighteners, induction heaters, and irons were found in the rooms during the
- During housekeeping, it was observed that lights and fans in most of the rooms were left on even when there were no students inside, resulting in unnecessary electricity consumption.

Night Policy

- ♦ The gates will be closed by 9:30 pm
- ★ The students are not allowed to be in the common area post 10pm
- ♣ The lights on common area will be dimmed post 10pm
- ★ The lights on the common area ground will be switched off post 10 pm
- No food parcels are allowed inside the hostel area post 10 pm
- ★ The lift will be operational from 6 am.
- Only students with prior written permission from their professors and subsequent prior approval from the warden will be allowed to enter the hostel premise post 9:30 pm.

Water Policy

♦ Hot water will be made available only from 6 am-9 am every day

Damage Policy

Common area

- + If any damage occurs to assets/equipment in a common area such as the gym, gaming zone, or gyani room due to misuse, then the entire hostel will be liable to pay the charges required for repair.
- If any equipment on the floor, such as the washing machine, cooler, induction, or microwave, is misused by students, then the entire floor will be liable to pay the charges required for repair and maintenance.
- If any damage occurs to the lift due to misuse, then all boys (for the boys' side lift) or all girls (for the girls' side lift) will be liable to pay the charges required for repair and maintenance.

Rooms

- → If any damage occurs to assets in the room (bed, mattress, study table, chair, wardrobe, wardrobe lock, main door, main door lock, sink, washroom, flush, etc.) due to misuse by the student, then the students in that particular room will be liable to pay the charges required for repair and maintenance.
- If any damage occurs to assets in the breakout zone, then the students on that particular floor will be liable to pay the charges required for repairing.
- Opening the doors to the balconies in the rooms is prohibited. If opened, the students of the room will be fined appropriately, and the doors will be relocked. The repairing cost will be further borne by the student

GUIDELINES FOR STUDENTS / CODE OF CONDUCT

- Students are permitted to stay at the hostel only when they are registered for any course at the university and are bonafide students with academic engagements.
- ★ The students are expected to stay in the allotted room for one complete year. Change/interchange of rooms in midsemester is not permitted.
- ★ The attendance timing is 8.45 pm to 9.45 pm daily at the reception desk.
- The hostellers are required to declare any chronic medical problems they may have at the time of admission. Such students, in case of an incident, may need to evacuate the room, as personal medical care by their parent/guardian will be necessary.
- → If a student is expelled from the university or involved in disciplinary action, they should immediately evacuate the hostel on the day of expulsion from the university. Their continuance in the hostel will be considered unauthorized, and no fees shall be refunded.
- + Hostellers are personally responsible for safeguarding their belongings at all times.
- + Hostellers are advised not to keep large amounts of cash (max. 3000) or valuables like gold, costly wristwatches, electronic gadgets, etc. in their rooms. In case of theft or loss of any items, it should be reported to the authorities.
- The hostel rooms will be inspected by the hostel authorities to ensure that they are kept neat and tidy, and no unauthorized items are kept in the room.
- ◆ Strict silence shall be observed in the hostel from 10.00 pm to 6.00 am. Any manner of festivities/celebrations that may disturb the decorum of the hostel should not be practiced.

- * Alcohol/Drugs/Smoking/Gambling is not permitted on the hostel premises.
- If any hosteller is found indulging in any form of instigation/intimidation/threat to any other hosteller, they will be asked to vacate the hostel forthwith.
- Students shall conduct themselves with decorum and dignity. They must observe self-imposed discipline in all
 activities.
- ★ The hostellers shall always dress decently and maintain the dignity of the premises.
- * Ragging in any form whatsoever is strictly banned. It is a cognizable offense, and a violation will invite action as per university norms.
- Any physical/mental harassment towards fellow students, including ragging, quarreling, using abusive language, and violent behavior, is prohibited.
- Any act of uploading derogatory remarks or an image ridiculing a person in the eyes of others against the university/hostel will invite disciplinary action.
- * All the students of the hostel should take their food in the allotted mess/dining hall as per the schedule. Students are expected to maintain the decorum of the dining hall.
- In cases of Non-Staying due to long-term internship, the mess charges will be waived, but the hostel fee remains to be paid in all situations.
- ♦ In case of damage to hostel property, the student is liable to pay the applicable charges.
- * Students can submit their leave request to the Warden three days before their departure. The Chief Warden may contact the Parents/University for verification if required.
- ➤ Students can leave the hostel or report back to the hostel only between 8 am to 9:45 pm. The hostel campus remains closed after 10 pm. Hostellers coming to the hostel after the gate closing hours without prior permission or without valid reason will undergo disciplinary action.
- * Collection of donations for any purpose (religious/otherwise) is also strictly prohibited.
- Students who wish to vacate the hostel at the end of the final year are directed to clear the hostel No-Dues procedure.
- Use water and electricity wisely. Students should turn off the switches while leaving the room daily.
- Students shall not stick any poster or paper in any form on any part of the room/wall, hostel wing corridor, bathroom, or common space of the hostel.
- The students are expected to develop a sense of belongingness, keep it upright and clean, and create a congenial environment conducive to studies.
- The students are exempted from residence in the hostel according to the criteria mentioned below:
- * Students residing within the geographical boundaries of Pune City and Pimpri Chinchwad city are exempted from the hostel facilitu.
- → Students must submit an exemption request in the prescribed format, along with valid residential proof as specified by the MIT-WPU Hostel management. The request shall be submitted prior to boarding the hostel and during the admission process. The exemption requests will not be entertained later than that. The yearly fees are applicable if the exemption request is received post-admission.
- Violation of any of the above-mentioned guidelines and unlawful behavior shall be avoided to continue the stay at the hostel premises.
- The hostel management reserves the right to continuation/confirmation/cancellation of admission. The decision remains applicable to the hosteller.

MEDICAL FACILITIES

- A doctor visits the hostel regularly for students. In case any student requires medical attention, they must immediately inform the caretaker/warden. The student will be given due attention in the form of proper medical care and taken to the hospital if required.
- ♦ A 24 x 7 ambulance service is available for students.
